Membership Activation – Membership is effective immediately upon paying the appropriate membership fee.

Membership Expiration – USA Water Ski membership expires 12 months from date of purchase. Family dependents' membership expiration will be the same as the family head-of-household.

Insurance Coverage – Only **Active** members may participate in USA Water Ski-sanctioned events. **Supporting** members must upgrade to **Active** status to participate.

Active members are eligible to receive secondary medical expense coverage of up to \$10,000 (subject to a \$1,000 deductible) for accidental injuries sustained during participation in any USA Water Ski-sanctioned event.

PARTICIPANT WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

ANNUAL Membership Waiver Form for ADULTS (Age 18 or older)

For and in consideration of USA Water Ski, Inc.
